Consumer Information

Auguste Escoffier School of Culinary Arts distributes a variety of publications that contain information regarding the school and its financial aid programs. If you do not have any of the following information and wish to obtain it, it will be furnished upon request.

- Financial aid programs that are available to students: how students apply for aid, how eligibility is determined, and how our school distributes aid among students
- The rights and responsibilities of students receiving aid
- How and when financial aid will be disbursed
- The terms and conditions of any employment that is part of the financial aid package
- The terms of, the schedules for, and the necessity of loan repayment and required loan exit counseling
- The criteria for measuring satisfactory academic progress, and how a student who has failed to maintain satisfactory progress may reestablish eligibility for federal financial aid
- Regulatory agencies that accredit, approve, or license our school and its programs
- Special facilities and services available to disabled students

- Our school return policy and the federal Return of Title IV funds requirements when a student withdraws from our school, including the order in which financial aid is refunded

- Information about our school's academic programs, facilities, and faculty
- Whom to contact for information on student financial assistance and for general school issues
- Terms and conditions under which students receiving federal education loans may obtain deferments
- Information regarding the availability of federal financial aid for any study abroad programs which we may participate in.
